- 3.入境流程：客人上飞机前请提供自拍照给我司，客人下飞机乘摆渡车到开罗机场海关，直接往海关边检方向走，到了边检旁边有个银行窗口，在窗口买 25 美金（以窗口收费为准）签证贴条贴护照签证页上，办理出关手续，出关后即可看到举牌人（牌上写客人名字）在关口等待接关，建议客人提前准备往返机票、酒店预订、现金 2000 美元
